To all to Whom these Presents shall come Greeting
Whereas Robert Daggitt of Lake County, Illinois has deposited in the General Land Office of the United States, a certificate of the Register of the Land Office at Chicago whereby it appears that full payment has been made by the said Robert Daggitt according to the provisions of the Act of Congress of the 24th of April 1820, entitled "An Act making further provision for the sale of the Public Lands" for the South East quarter of Section Thirty six, in Township Forty three North of Range Twelve East, in the District of Lande subject to sale at Chicago Illinois, containing One hundred and Sixty acres, according to the official plat of the survey of the said Lands, returned to the General Land Office by the Surveyor General which said tract has been purchased by the said Robert Daggitt Now Know Ye, That the United States of America in consideration of the premises, and in conformity with the several Acts of Congress in such case made and provided, Have Given and Granted and by these Presents Do Give and Grant, unto the said Robert Daggitt and to his heirs, the said tract above described, To Have and to hold the same together with all the rights privileges, immunities and appurtenances of whatsoever nature thereunto belonging or unto the said Robert Daggitt and to his heirs and assigns forever.

In Testimony Whereof, I John Taylor President of the United States of America have caused these letters to be made Patent, and the seal of the General Land Office to be hereunto affixed Given under my hand at the city of Washington, the tenth day of March in the year of our Lord one thousand eight hundred and forty three and of the Independence of the United States the Sixty seventh
